11. Remarks for the Good of the Order:

Rob Hodgeman discussed the Cascadia Subduction Zone: roughly 70 airports will be affected by the event. FEMA has the ability to conduct an assessment on existing infrastructure and to rank priority response airports. The FAA has also approached WSDOT on doing a study on load bearing capacity to determine what airports are capable of handling would be response aircraft. WSDOT has been approached to research and put together a reference book with inventory on 30 airports in Western Washington. A future presentation on the preparation for the Cascadia Subduction Zone event to the membership may be in order.
