In 2019 the newly established Virtower began research into the current aircraft tracking solutions and their limitations.

Launching in October 2020 Virtower now has over 200 Airports using the system to track operations, pavement usage and investigate noise complaints. Virtower acceptance at a state level has resulted in being eligible for Grants in Indiana, Kentucky, North Carolina, Tennessee, Texas, and Utah. In early 2022 Virtower was selected to provide tracking of interagency government air assets for deconfliction and coordination with drone operations in congested airspace for the US Department of Homeland Security.
